



Asheville JCC Aquatics Party Contract

The first step in hosting your party at the JCC is completing this contract and submitting it with a non-refundable deposit to wendy@jcc-asheville.org at least two weeks prior to the requested party date. Submission of this birthday party contract does not guarantee a reservation. After receiving the contract and deposit, a member of the JCC aquatics staff will contact you to confirm your party reservation and ensure that you have a valid credit card on file in our system. Aquatics party renters must be JCC members, but party guests do not need to be JCC members.



Party Package Options

Package 1: MEMBER FAMILY + 5 GUESTS

Price: Free for member family + \$8 per child guest (0-18) and \$10 per adult guest

Deposit Amount: none

Guests: Member family plus 5-guest maximum. A guest is anyone attending the party in the aquatics facility – whether or not they plan to swim.

Price Includes:

- Use of aquatics facility by member family plus up to five additional guests. Please note - this option does not include the use of the party room or pavilion area

Package 2: OUTDOOR PAVILION AND DURING-HOURS POOL

Rental Price: \$75 per hour with a minimum of two hours and a maximum of 4 hours

Deposit Amount: \$50 submitted with contract, can be applied to the final cost

Guests: The party price includes immediate household members + 15 guests. Up to 10 additional guests can be added at \$5 per guest. A guest is anyone attending the party in the aquatics facility – whether or not they plan to swim.

Price Includes:

- Four picnic tables under the covered pavilion and the grassy area
- Use of the indoor refrigerator/freezer, microwave, and locker rooms
- Designated JCC Party Assistant who will assist you during your party

Additionally:

- Unfortunately, due to the high volume of member families who use our pool, we cannot allow floats. Keep this in mind when planning your day. Noodles, puddle jumpers, and lifejackets are all acceptable and are available for use at the pool.

Package 3: AFTER-HOURS PRIVATE RENTAL

Rental Price: \$400 for a two-hour rental from 8:15-10:15 pm

Deposit Amount: \$100 submitted with contract, can be applied to the final cost

Guests: 50-person maximum. A guest is anyone attending the party in the aquatics facility – whether or not they plan to swim.

Price Includes:

- Private use of pool, pool deck, covered pavilion, grassy area, and locker rooms.
- Use of the indoor refrigerator/freezer and microwave
- Designated JCC Party Assistant who will assist you during your party

Additionally:

- Floats will be allowed for private parties but no more than one giant-sized floats
- Due to the Asheville City Noise Ordinance, all music and loud noises must come to an end at 10:00pm sharp.

Terms & Conditions

Venue Access

Parents will have access to the reserved area 30 minutes prior to the party's scheduled start time. Guests will not be allowed into the reserved area prior to the party's scheduled start time. All party attendees must leave the reserved area no later than 30 minutes after the party's scheduled end time.

Set-up and Clean-up

The JCC is not responsible for set-up, clean-up, decorations, or supplies. Trash cans are available on-site for easy clean up. All trash and debris must be placed inside the designated receptacles prior to vacating the reserved area.

Parents may bring decorations as they see fit, with the following restrictions:

- No decorations may be "pinned" or nailed to any surface.
- No flames aside from candles on birthday cakes.
- No glitter or confetti

Food/Drink:

- You may bring food and beverages to serve during the birthday party, and store them in our refrigerator and freezer.
- No glass is to be brought into the facility. If a member of the staff discovers glass we will ask you to remove the containers from the facility. This includes Pyrex dishes, drinks in glass bottles, condiments such as salsa, wine glasses, etc.
- All food and drink must be removed from the reserved area and Aquatics Center refrigerator and freezer no later than 30 minutes after the party's scheduled end time.

Guest Conduct

Children must be supervised by an adult at all times. All guests are expected to behave responsibly at all times.

Cancellations and Refunds

A 24-hour cancellation is required or the deposit will become non-refundable. A full or partial refund will be provided if weather or facility closure prevents a rental period from taking place (*ex. If a 4-hour rental is stormed out for 2 hours, the renter will only be charged for 2 hours*).

Liability

- Assumption of Risk. Legal Representative acknowledges and understands that participation by Members in the Program and the use of JCC facilities may involve certain risks of personal injury(ies), illness, permanent disability, and/or death ("Risks"). These Risks include, but are not limited to: exposure to and/or infection with Covid-19 and/or other viruses and/or bacterial infection; participation in aquatics activities both indoors and outdoors in a permitted setting under regulatory guidance from the North

Carolina Department of Health and Human Services and Buncombe County Environmental Health. Legal Representative assumes the Risks on behalf of Members, both known and unknown, of participating in the Program and using the JCC facilities. Regarding Covid-19, Legal Representative understands that even if the JCC follows all guidelines for the prevention and handling of Covid-19, there is still a Risk that Members could contract the disease.

- Release from Liability. On behalf of Members, Legal Representative agrees to waive, discharge claims, and release the JCC, its directors, employees, agents, and independent contractors from any and all liability relating to the Risks resulting from Members' participation in the Program and/or use of JCC facilities. In addition, the JCC shall have the benefit of any future liability immunity or protection related to the Covid-19 pandemic which applies to organizations or businesses passed by any governmental entity to which JCC is subject.
- Indemnification. Legal Representative agrees to indemnify and defend the JCC against all claims, causes of action, damages, judgments, costs, and/or expenses, including attorneys' fees and other litigation costs, which may arise from Members' participation in the Program and/or use of the JCC facilities.
